- C.** **The Municipal Clerk shall cause the Assembly to have the opportunity to vote on reauthorization of a board or commission by ordinance, submitted through the Assembly Chair at least 90 days prior to sunset, and the recommendation from the Administration may be included by informational memorandum.**
